



## Club Miata Vancouver Island Privacy Statement

Personal Information: Means information about an identifiable individual and includes members' personal information but does not include contact information. In complying with the new *Privacy Act* of January 2<sup>nd</sup>, 2004, we provide the following information:

Most of the information that we collect is from personal contact, by phone contact, or received from you through the internet. We only collect information necessary to maintain our records and for our own members' use. Most of this information could be considered public in nature.

### **We do not share, sell, or provide any information we have.**

As we get this information from you we consider this to be consent to maintain our records. Should you wish to have us make your information available to other members of Club Miata Vancouver Island, it is necessary for you to give us permission. We spend considerable effort to safeguard our records from unauthorized access and the personal information received through the Membership Application / Privacy Statement Agreement, and only that of which is authorized by you on the Application Form, may be presented for Club Members use only.

We require your authorization as to what information will be included in our Membership Contact Lists available to Club Miata Members Only. The Contact List is produced by way of a printed Membership Roster. Please be assured that your personal information is never given out to a non-member of Club Miata Vancouver Island and the onus falls on each and every one of our members to ensure that the information of all members are protected and due diligence is maintained on any copies of the Rosters or Membership contacts they may have in their possession.

Club members may be taking pictures during our runs and social events. If you do not wish to have your picture taken and/or shared, we respectfully ask that you do not insert yourself into group photos. You may also wish to park away from the group of Club Miata to avoid your car being included in group car photos. We wish to respect your privacy, but we have no control over what people do with pictures of our members and their cars. Club Miata Vancouver Island will not accept responsibility and will not be held liable for the end use of these pictures. It is your responsibility to ensure you are not in the photos that club members or members of the public take during club runs and social events.

By completing and signing the Membership Application or Renewal Application, you are hereby acknowledging and agreeing to the terms set out by Club Miata Vancouver Island and those within the Privacy Act of British Columbia. The onus will fall upon each new or renewing member to complete the forms in full, including the Privacy Statements on these forms, as shown below. Any incomplete authorizations will be assumed that you are in agreement and accept our Policy Statements as stated above.

By completing and signing the Membership Application or Renewal Application, you are hereby acknowledging and agreeing to the terms set out by Club Miata Vancouver Island, as amended from time to time. All members will be notified of such amendments when and if they occur. By completing and signing our Club Application, you also acknowledge and agree to the terms set out in the Privacy Act of British Columbia.

Throughout the year we produce Club Membership Rosters which provides a list of our members, that is limited to current members who have requested membership in Club Miata Vancouver Island. The roster information includes such information as your names, address, primary phone, e-mail addresses, and car details.

**Check here if you do NOT want your information listed in the Roster or released to Club members.** If you do not want your information shared exclusively with members, then only your names and car details will appear.

Members of the Club may be taking pictures of the runs and socials. We wish to respect your privacy, but we do not have control over what members, or the general public, do when taking pictures. If you do not wish to have your picture shared or posted, we respectfully ask that you do not insert yourself in group photos. You may also wish to park away from the group of Miatas to avoid your car being included in group car photos. It is your responsibility to ensure you are not in the photos that members or the public take during runs and socials. Thank you.
